Dear Sir,

Please refer to my letter of even number dated 30-7-07 to Director, SCERT, UP regarding non recognition of IGNOU B.Ed. programme by the Govt. of UP for admission to Special BTC training. A copy of the letter is enclosed for ready reference.

2. We have now received another letter from Vice Chancellor IGNOU referring to the news item published in the Lucknow Edition of Hindi daily "Hindustan" on 21-7-07. A copy of the letter of Vice Chancellor IGNOU alongwith its enclosures is enclosed for your convenience.

3. You may kindly recall that while giving approval to Govt. of UP for conduct of Special BTC we have allowed all B.Eds to be eligible for the above course as requested by Govt. of UP. No difference was made regarding B.Ed. (Face-to-Face) and B.Ed. (Distance Mode). As such, the degree awarded by IGNOU, a Central University and institution/university recognized by the NCTE cannot be treated as inferior to other B.Eds.

4. I shall be grateful if you take immediate action on the above issue and treat the degrees awarded by IGNOU at par with similar degrees obtained through face to face mode under intimation to us and IGNOU to avoid any litigation at later stage.
